Opinion

1. We have reviewed the accompanying statement of Unaudited Standalone Financial Results ('the Statement') of **M/s Kabirdas Investments Limited** ('the Company') for the quarter and half year ended 30th September, 2023 ('the statement'), attached herewith, being submitted by the Company pursuant to the requirement of Regulation 33 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, as amended (hereinafter referred as "the Regulation") read with relevant circulars issued by the SEBI from time to time.

This standard requires that we plan and perform the review to obtain moderate assurance as to whether the financial statements are free of
