“The compliance with the corporate governance provisions as specified in regulations 17, 17A, 18, 19, 20, 21,22, 23, 24, 24A, 25, 26, 26A, 27 and clauses (b) to (i) and (t) of sub-regulation (2) of regulation 46 and para C , D and E of Schedule V shall not apply, in respect of –

*(a) listed entity having **paid up equity share capital not exceeding rupees ten crore and net worth not exceeding rupees twenty-five crore**, as on the last day of the previous financial year:*

Provided that where the provisions of regulations 17 to 27, clauses (b) to (i) and (t) of sub-regulation (2) of regulation 46 and para C, D and E of Schedule V become applicable to a listed entity at a later date, it shall ensure compliance with the same within six months from such date.”

Provided further that once the above regulations become applicable to a listed entity, they shall continue to remain applicable till such time the equity share capital or the net-worth of such entity reduces and remains below the specified threshold for a period of three consecutive financial years.

With regard to same, we would like to draw your kind attention that the paid-up capital of the company **does not exceed rupees Ten Crore and Net Worth does not exceed rupees Twenty-Five Crore.** Hence the company is not required to submit Corporate Governance Report for the quarter ended on 30th June, 2025, since it's exempted under Regulation 15(2)(a) of SEBI (Listing Obligations & Disclosure Requirements) Regulations 2015.
